## 2022 Annual General Assembly

The 2022 Annual General Assembly (AGA) of the Federation of Gay Games is to take place between Friday 4<sup>th</sup> November and Monday 7<sup>th</sup> November (am only) 2022. The Meeting will be held in Guadalajara, Jalisco, Mexico.

This is the formal Notice of Meeting.

The meeting will take place as an in-person event. An option to join the meeting to participate or observe on line will also be made available to those unable to travel.

## **Business**

## 1. Opening of the Meeting

The meeting will:

- approve the agenda for the meeting
- have the purpose of the FGG read aloud
- consider the minutes of the 2021 Annual General Assembly (Brighton)

Following the publication of the minutes on or before 3<sup>rd</sup> October 2022, the Co-Presidents will invite the General Assembly to submit questions about or comment on the minutes. Questions must be received at <a href="mailto:AGA2022@gaygames.net">AGA2022@gaygames.net</a> by 31<sup>st</sup> October 2022.

#### 2. Election of Directors

The following positions are declared vacant at the meeting. Each position is for a 4-year term:

- Co-President
- Vice President External Affairs
- Officer Host Relations
- Officer Technology
- Officer Site Selection

The following position is declared vacant and open for election for a 2-year term.

One Officer at Large

Following resignations earlier in the year, there will be two additional vacancies with one year remaining on the term:

- Officer Ceremonies
- Officer at Large

In addition, there will be a confirmatory vote for the new

Officer of Sport (Reggie Snowden) Vice President – Member Services (Jamie Hooper)

Nominations from suitably qualified people are now sought for these positions. Please refer to the FGG bylaws regarding qualifications for each of these roles. Role descriptions for each of the vacant positions can be found HERE

The following positions are for varying term lengths as the transitional arrangements for 4-year terms are implemented

- Vice President Production (2 years)
- Treasurer (1 year)
- Secretary (1 year)
- Officer Culture (3 years)
- Officer Human Resources (2 years)
- Officer Sports (Female) (I year)

Please note that other positions may be available for election. These will be identified as and when they are known.

Nominations must be received in writing by the FGG (AGA2022@gaygames.net) no later than 14<sup>th</sup> September 2022 and must be on the form enclosed with this Notice of Meeting, CV, and a photograph of yourself. Late submissions will be considered up to 14<sup>th</sup> October 2022.

On **4**<sup>th</sup> **November 2022** at the AGA all candidates will be called to speak for one minute on why you wish to be elected to the chosen position.

For a candidate to be elected to the FGG Board, they require a majority of the General Assembly. If 1 or 2 candidates are nominated, voting will be by simple majority of the General Assembly. If more than 2 candidates are nominated for any position, instant run-off voting will be used to determine the candidate to be appointed to the FGG Board.

# 4. Presentation by our Co-Hosts Guadalajara and Hong Kong 2023

Both the Organising Committee from Guadalajara and the Organising Committee from Hong Kong will be given the opportunity to make a short presentation to the General Assembly.

Following the presentations, the General Assembly will be given the opportunity to ask questions.

In addition the Hong Kong Team will be showing (by video) the main sports and culture venues to be used for the Games in Hong Kong 2023

The Guadalajara Team will be providing a bus tour in Guadalajara showing the main sports and culture venues for the Games in Guadalajara 2023.

# 5. Presentation by Gay Games Valencia 2026

Team Valencia 2026 will be given an opportunity to make a short presentation to the General Assembly.

Following the presentation, the General Assembly will be given the opportunity to ask questions.

#### 6. Consideration of Reports

The Annual Report and Financial Report for the year ended 30 June 2022 will be presented for consideration.

Each member will receive a copy of the Annual Report and Financial report for the year ended 30 June 2022 via the gay games email account. This will be sent out on or before 3<sup>rd</sup> October 2022...

Following the receipt of these Reports, the Co-Presidents will invite the General Assembly to submit questions about or comment on the Annual Report, Financial Report and management of the FGG. Questions should be submitted by **14**<sup>th</sup> **October 2022**. Questions will be answered at the AGA.

The motion will then be put to accept the Reports.

## 5. Bylaw Changes

Bylaw change requests need to be sent to the FGG (<u>AGA2022@gaygames.net</u>) no later than **14**<sup>th</sup> **September 2022**. These will be shared with the General Assembly on or before 3<sup>rd</sup> October 2022. Please use the attached Bylaw Amendment Form.

Any other motions which you may wish to be debated on the floor should be notified to the FGG Secretary (AGA2022@gaygames.net) before 30<sup>th</sup> September 2022 These will be shared with the General Assembly on or before 3<sup>rd</sup> October 2022 Any motions not received by this date will only be presented to the AGA if approved by majority decision for discussion by the General Assembly.
